8 OF BOATING AND WATERWAYS, VESSEL TURN IN
9 PROGRAM (VTIP) UNDER THE ABANDONED
10 WATERCRAFT ABATEMENT FUND (AWAF) GRANT
11 PROGRAM FOR THE REMOVAL OF SURRENDERED
12 VESSELS FROM THE NAVIGABLE WATERS AND
13 MARINAS IN LONG BEACH

15 WHEREAS, the State Department of Parks and Recreation, Division of
16 Boating and Waterways, provides grant funds to cities, counties and districts for the
17 removal of voluntarily surrendered vessels; and

18 WHEREAS, the City of Long Beach is desirous to receive funds for the
19 removal of surrendered vessels;

20 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
21 follows:

22 Section 1. That the application for and acceptance of \$5,000 in grant
23 funds from the State Department of Parks and Recreation, Division of Boating and
24 Waterways, for the removal of surrendered vessels is necessary.

25 Section 2. The City certifies that it has or will have funds available to
26 operate and maintain the project.

27 Section 3. The City Manager is authorized to conduct all negotiations,
28 and execute and submit all documents including, but not limited to, applications,
