THIS THIRD AMENDMENT TO AGREEMENT NO. 30762 is made and entered, in duplicate, as of April 18, 2011, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 10, 2008, by and between ITERIS, INC., a Delaware corporation, with a place of business at 1700 Carnegie Avenue, Suite 100, Santa Ana, California 92705 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City and Consultant entered into Agreement No. 30762 for the performance of specialized services in connection with As-Needed Transportation Engineering, Transportation Planning, and Related Technical and Professional; and

WHEREAS, the parties desire to extend the term;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and in this Amendment, the parties agree as follows:

1. Section 2 of Agreement No. 30762 is amended in its entirety to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on June 10, 2008, and shall terminate at 11:59 p.m. on June 10, 2012, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 30762 are ratified and confirmed and shall remain in full force and effect.
