FIFTEENTH AMENDMENT TO CONTRACT NO. 28970

- 1. The term of the Contract is hereby extended so that the Contract will remain in effect through June 30, 2012.
- 2. As of January 1, 2012, the price for the Supplemental Law Enforcement Services to be provided by LBPD to Center under the Contract shall be at the rates provided for in Exhibit "A" attached hereto.
- Except as expressly amended herein, all of the terms and conditions of Contract No. 28970 as amended, are ratified and confirmed and shall remain in full force and effect.
