3 THIS FIFTEENTH AMENDMENT TO CONTRACT NO. 28970 is made and  
4 entered, in duplicate, as of November 15, 2011, for reference purposes only, pursuant to  
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 July 6, 2004, by and between CREA/PPC LONG BEACH TOWNE CENTER PO, LLC, a  
7 Delaware limited liability company, with offices located at 7575 Carson Boulevard, Long  
8 Beach, California 90808 ("Center") and the CITY OF LONG BEACH, a municipal  
9 corporation ("City").

10 WHEREAS, the parties entered into Contract No. 28970 and fourteen (14)  
11 Amendments thereto, whereby City agreed to provide supplemental law enforcement  
12 services to the Long Beach Towne Center over and above the law enforcement services  
13 provided to the public generally; and

14 WHEREAS, the parties desire to extend the term of the Contract and  
15 amend the rates for the Supplemental Law Enforcement Services to be provided by  
16 LBPD to Center;

17 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
18 Contract No. 28970 and all Amendments thereto, the parties agree as follows:

19 1. The term of the Contract is hereby extended so that the Contract will  
20 remain in effect through June 30, 2012.

21 2. As of January 1, 2012, the price for the Supplemental Law Enforcement  
22 Services to be provided by LBPD to Center under the Contract shall be at the rates  
23 provided for in Exhibit "A" attached hereto.

24 3. Except as expressly amended herein, all of the terms and conditions of  
25 Contract No. 28970 as amended, are ratified and confirmed and shall remain in full force  
26 and effect.
