I am submitting the following conditions for your consideration for the application of a person-to-person and premise-to-premise transfer of an On-Sale General license for a bonafide eating place.

- 1. The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control.
- 2. The permittee shall not allow employees to discard trash or bottles into the outside dumpsters between the hours of 10 p.m. and 8 a.m.
- 3. There shall be no exterior advertising promoting or indicating the availability of alcoholic beverages.
- 4. Sound shall not be audible within fifty feet (50') from the exterior of the premises in any direction.
- 5. The permittee shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside the establishment at all times.
- 6. Sales, service and consumption of alcoholic beverages shall be permitted only between the hours of 11:00 a.m. and 12:00 midnight, Sunday thru Thursday, and 11:00 a.m. thru 1:00 a.m., Friday and Saturday.
- 7. The quarterly gross sales of alcoholic beverages shall not exceed the gross sales of food during the same period. The licensee shall at all times maintain records which reflect separately the gross sales of food and the gross sales of alcoholic beverages of the licensed business. Said records shall be kept no less frequently than on a quarterly basis and shall be made available to the Department on demand.
- 8. The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
- 9. "Happy hour" type of reduced price alcoholic beverage promotion shall be allowed only between the hours of 4 p.m. to 7 p.m.

10. The permittee shall install and maintain a video surveillance system that monitors no less than the front and rear of the business with full view of the public right-of-ways and any parking lot under the control of the permittee. The video system must be capable of delineating on playback the activity and physical features of persona and areas within the premises. Recordings shall be retained for a minimum of 30 days and be accessible via the internet by the Long Beach Police Department. A Public Internet Protocol (IP) address and user name/password is also required to allow the Long Beach Police Department to view live and recorded video from these cameras over the internet. All video security cameras shall be installed to the satisfaction of the Chief of Police, Director of Technology Services, and Director of Development Services. At the discretion of the Chief of Police, the permittee may be required to add additional video cameras.
