3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE A CONTRACT AND ANY
6 AMENDMENTS THERETO WITH RAY GASKIN SERVICE
7 WITHOUT ADVERTISING FOR BIDS FOR NEW WAY,
8 PERKINS AND WAYNE BRAND REFUSE TRUCK PARTS
9 AND REPAIR SERVICES IN AN AMOUNT NOT TO EXCEED
10 \$302,500

12 WHEREAS, the City of Long Beach fleet has a total of eighty-four (84)
13 refuse trucks currently in service; and

14 WHEREAS, of these trucks, forty-three (43) have either New Way or
15 Wayne service bodies, twenty (20) are out of warranty, another ten (10) will be out of
16 warranty on September 30, 2018 and the remaining thirteen (13) will be out of warranty
17 by then end of November 2018; and

18 WHEREAS, of the 41 remaining McNeilus refuse trucks used by the City,
19 20 are scheduled to be replaced in FY18 with new trucks that have either New Way or
20 Wayne refuse truck bodies; and

21 WHEREAS, Ray Gaskin is the sole authorized distributor and service
22 center for New Way, Perkins, and Wayne refuse truck parts and service in the state of
23 California; and

24 WHEREAS, as a result, no useful purpose would be served by advertising
25 for bids and to do so would constitute an idle and useless act and an unnecessary
26 expenditure of public funds;

27 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
28 follows:

1 Section 1. The above recitals are true and correct and are incorporated
2 herein.

3 Section 2. The City Manager is hereby authorized to enter a contract and
4 any amendments thereto with Ray Gaskin Service for the New Way, Perkins and Wayne
5 brand refuse truck parts and repair services in an amount not to exceed Three Hundred
6 Two Thousand Five Hundred Dollars (\$302,500), for a period of two years, with the
7 option to renew for three additional one-year periods, at the discretion of the City
8 Manager.


9 Section 3. This resolution shall take effect immediately upon its adoption
10 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

11 I hereby certify that the foregoing resolution was adopted by the City
