## RECOMMENDATION:

Authorize the Director, or his or her management designee, to execute a new Fitness Provider Permit and amend Attachment "A" of the Permit as needed.

## DISCUSSION

Pursuant to Section 16.16.060 of the Long Beach Municipal Code, Parks and Recreation Commission approval is required of all Fitness Provider Permits for individuals and businesses wishing to use open park space for group exercise classes, personal training and/or boot camps within City parks (Commercial Recreation/Instruction). As of June 1, 2016, the Department of Parks, Recreation and Marine (PRM) has received one new request for Commercial Recreation/Instruction within City parks. A summary of the aforementioned requested Fitness Provider Permit to be approved for the third quarter of fiscal year 2016 is attached for your consideration and approval.

## FISCAL IMPACT:

The Suggested Action will result in annual revenue in the amount of \$350, which shall accrue to the General Fund (GP) in the Department of Parks, Recreation and Marine (PR). If the Director approves additional sites, annual revenue will increase by a pro-rated amount per month or \$350 per year, per site.
