Hi Amber and Danny - The Marine Bureau staff has been conducting site inspections at the Rainbow Harbor docks over the past few weeks, in an effort to evaluate current practices and the general conditions of the grounds. Through these inspections we have identified various maintenance issues that our staff will address, and have also identified some other issues/practices that we are asking operators in the harbor to correct to present the overall property at a high shared appearance standard.

One such item identified with several of the operators (including the Harbor Breeze location) is the use of vinyl promotional banners - displayed from the gangways and suspended from palm trees along the promenade. While I understand these practices have gone on for some time, they are not authorized, they detract from the overall aesthetic of the Harbor, are contrary to the property's original architectural intent (as the gangways are up lit at night and the row of palms weren't intended for such use), and the practice may damage trees that support local wildlife. As such, we're looking to sunset both practices in the coming weeks.

Understanding the Harbor Breeze is now in the heart of your peak season summer activities, we are requesting you and your team remove any such banners from gangways or suspended from palm trees by the mid September 2016.

Thank you in advance for your help as we work towards these appearance goals for the overall property. Please call me if you have any questions or concerns.
