1 FIRST AMENDMENT TO CONTRACT NO. 32297

3 THIS FIRST AMENDMENT TO CONTRACT NO. 32297 is made and  
4 entered, in duplicate, as of August 1, 2012, for reference purposes only, pursuant to  
5 Resolution No. RES-11-0084, adopted by the City Council of the City of Long Beach at its  
6 meeting on August 2, 2011, by and between DOOLEY ENTERPRISES, INC., a California  
7 corporation ("Contractor"), with a place of business at 1198 N. Grove Street, Suite A,  
8 Anaheim, California 92806, and the CITY OF LONG BEACH ("City"), a municipal  
9 corporation.

10 WHEREAS, the parties entered Contract No. 32297 whereby Contractor  
11 agreed to provide Winchester factory-loaded ammunition; and

12 WHEREAS, the parties desire to extend the term and add \$354,000 for a  
13 total not to exceed amount of \$708,000;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
15 conditions in Contract No. 32297 and herein, the parties agree as follows:

16 1. Section 2 of Contract No. 32297 is hereby amended in its entirety to  
17 read as follows:

18 "2. City shall pay Contractor in due course of payments, following  
19 receipt of an invoice from Contractor and upon acceptance from City, for Winchester  
20 factory-loaded ammunition the prices shown in Exhibit "A", a sum not to exceed Seven  
21 Hundred Eight Thousand Dollars (\$708,000). The parties have the option to renew this  
22 Contract for one (1) additional one (1) year period."

23 2. Section 3 of Contract No. 32297 is hereby amended in its entirety to  
24 read as follows:

25 "3. The term of this Contract shall commence on August 15, 2011, and  
26 shall terminate at midnight on August 15, 2013 unless sooner terminated as provided  
27 herein. The City may terminate this Contract by giving thirty (30) days prior notice of  
28 termination to Contractor."




