FIRST AMENDMENT TO CONTRACT NO. 32297

THIS FIRST AMENDMENT TO CONTRACT NO. 32297 is made and entered, in duplicate, as of August 1, 2012, for reference purposes only, pursuant to Resolution No. RES-11-0084, adopted by the City Council of the City of Long Beach at its meeting on August 2, 2011, by and between DOOLEY ENTERPRISES, INC., a California corporation ("Contractor"), with a place of business at 1198 N. Grove Street, Suite A, Anaheim, California 92806, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, the parties entered Contract No. 32297 whereby Contractor agreed to provide Winchester factory-loaded ammunition; and

WHEREAS, the parties desire to extend the term and add \$354,000 for a total not to exceed amount of \$708,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in Contract No. 32297 and herein, the parties agree as follows:

- 1. Section 2 of Contract No. 32297 is hereby amended in its entirety to read as follows:
- "2. City shall pay Contractor in due course of payments, following receipt of an invoice from Contractor and upon acceptance from City, for Winchester factory-loaded ammunition the prices shown in Exhibit "A", a sum not to exceed Seven Hundred Eight Thousand Dollars (\$708,000). The parties have the option to renew this Contract for one (1) additional one (1) year period."
- 2. Section 3 of Contract No. 32297 is hereby amended in its entirety to read as follows:
- "3. The term of this Contract shall commence on August 15, 2011, and shall terminate at midnight on August 15, 2013 unless sooner terminated as provided herein. The City may terminate this Contract by giving thirty (30) days prior notice of termination to Contractor."

3. Except as expressly r	modified herein, all of the terms and conditions
contained in Contract No. 32297 are ratified and confirmed and shall remain in full force	
and effect.
