ORDINANCE NO. C-7935

AN ORDINANCE OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH AMENDING THE LONG BEACH  
MUNICIPAL CODE BY AMENDING SECTION 10.32.110  
RELATING TO PREFERENTIAL PARKING DISTRICT "F"  
AND REPEALING DISTRICT "N"

WHEREAS, by separate action, the City Council has acted to modify  
Preferential Parking District "F"; and

WHEREAS, the City Traffic Engineer has determined that establishing  
reasonably self-contained areas of parking demand and supply in the creation of  
preferential parking districts requires modification to the boundaries of Preferential  
Parking District "F" as well; and

WHEREAS, the change proposed here expands the existing preferential  
parking boundaries, to better define self-contained areas of parking demand and  
supply; and

WHEREAS, Pepperwood Avenue between Village Road and Harvey  
Way are within District "N" and are within the new boundaries of District "F" which  
would consolidate both districts; and

NOW, THEREFORE, the City Council of the City of Long Beach does  
hereby ordain as follows:

Section 1. District "F" of Section 10.32.110 of the Long Beach Municipal  
Code is hereby amended to read as follows:

District "F" : Village Road between Blackthorne Avenue and  
Faculty Avenue; Greenmeadow Road between Faculty Avenue and a  
point two hundred twenty-five feet east of Village Road; Sunfield Avenue

1 between Harvey Way and Centralia Street; Whitewood Avenue between  
2 Harvey Way and Centralia Street; Clark Avenue between Carson Street  
3 and Centralia Street; Greenbrier Road between Carson Street and  
4 Centralia Street; Heather Road between Carson Street and Centralia  
5 Street; Charlemagne Avenue between Carson Street and Centralia  
6 Street; Harvey Way between Rutgers Avenue and Pepperwood Avenue;  
7 Warwood Road between Faculty Avenue and Blackthorne Avenue;  
8 Faculty between Carson Street and Centralia Street; Graywood Avenue  
9 between Harvey Way and Centralia Street; Blackthorne Avenue between  
10 Village Road and Centralia Street; Hazelbrook Avenue between Harvey  
11 Way and Centralia Street; Pepperwood Avenue between Village Road  
12 and Centralia Street; the north side of Carson Street between the alley  
13 east of Norse Way and Faculty Avenue; and the north side of Carson  
14 Street between Clark Avenue and Charlemagne Avenue.

15  
16 Sec. 2. District "N" of Section 10.32.110 of the Long Beach Municipal  
17 Code is hereby repealed.

18  
19 Sec. 3. The City Clerk shall certify to the passage of this ordinance by  
20 the City Council of the City of Long Beach and cause the same to be posted in three  
21 conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first  
22 day after it is approved by the Mayor.




