1 FIFTH AMENDMENT TO AGREEMENT NO. 34674

3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 34674 is made and
4 entered, in duplicate, as of June 25, 2019, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on March
6 5, 2019, by and between CSG CONSULTANTS, INC., a California corporation
7 ("Consultant"), with a place of business at 3707 West Garden Grove Boulevard, Suite 100,
8 Orange, California 92868, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
11 34674 (the "Agreement") whereby Consultant agreed to provide as-needed plan review
12 and inspection services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 add \$120,000 for a total not to exceed amount of \$200,000; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to add \$140,000 for a total not to exceed amount of \$340,000; and

17 WHEREAS, the Parties entered into a Third Amendment to the Agreement
18 to add \$30,100 for a total not to exceed amount of \$370,100; and

19 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
20 to add \$6,500 for a total not to exceed amount of \$376,600; and

21 WHEREAS, the Parties desire to add \$73,900 for a total not to exceed
22 amount of \$450,500 and extend the term one (1) additional one-year period;

23 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
24 conditions herein contained, the Parties agree as follows:

25 1. Section 1.A. of the Agreement is hereby amended to read as:

26 "A. Consultant shall furnish specialized services more particularly
27 described in Exhibit "A", attached to this Agreement and incorporated by this
28 reference, in accordance with the standards of the profession, and City shall pay for

1 these services in the manner described below, not to exceed Four Hundred Fifty
2 Thousand Five Hundred Dollars (\$450,500), at the rates or charges shown in Exhibit
3 "B".

4 2. Section 2 of the Agreement is hereby amended to read as follows:

5 "2. TERM. The term of this Agreement shall commence at midnight on
6 August 1, 2017, and shall terminate at 11:59 p.m. on July 31, 2020, unless sooner
7 terminated as provided in this Agreement, or unless the services or the Project is
8 completed sooner. The term may be renewed for one (1) additional one-year period, at
9 the discretion of the City Manager."

10 3. Except as expressly amended herein, all of the terms and conditions
11 in Agreement No. 34674 are ratified and confirmed and shall remain in full force and effect.
