DBA VECTORUSA, a California corporation ("Contractor"), with a place of business at 20917 Higgins Court, Torrance, California 90501, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed video surveillance installation, repair, and maintenance to new and existing systems; and

WHEREAS, the Parties entered into a First Amendment to extend the term of the Agreement to January 4, 2024; and

WHEREAS, the Parties currently desire to increase the contract amount to \$1.500,000:

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Contractor shall furnish specialized services more particularly described in Exhibit "A-2", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Million Five Hundred Thousand Dollars (\$1,500,000), at the rates or charges shown in Exhibit "B"."
- 2. Except as expressly modified herein, all of the terms and conditions contained in this Agreement are ratified and confirmed and shall remain in full force and effect.
