THIS THIRD AMENDMENT TO AGREEMENT FOR LEGAL SERVICES is made and entered, in duplicate, as of April 27, 2022, for reference purposes only, by and between HURRELL & CANTRALL, LLP ("Special Counsel") and the CITY OF LONG BEACH, a municipal corporation ("City") amending that certain agreement ("Agreement") between Special Counsel and City and identified by the City as Agreement No. 35733.

WHEREAS, Purchase Order No. 32000565 was issued for Legal Services with Special Counsel in an initial amount not-to-exceed \$200,000; and

WHEREAS, an Agreement for Legal Services No. 35733 with Special Counsel was entered into, pursuant to City Council approval on November 17, 2020, to increase the amount by \$50,000; and

WHEREAS, a First Amendment to Agreement No. 35733 with Special Counsel was entered into, pursuant to City Council approval on June 8, 2021, to increase the amount by \$100,000; and

WHEREAS, a Second Amendment to Agreement No. 35733 for Legal Services is necessary to increase the amount by \$100,000 in connection with the matter entitled Suzzane Gordin vs. City of Long Beach, LASC Case No. 19STCV07941.

WHEREAS, a Third Amendment to Agreement No. 35733 for Legal Services was entered into, pursuant to City Council approval on April 19, 2022, to increase the amount by \$100,000 in connection with the matter entitled Suzzane Gordin vs. City of Long Beach, LASC Case No. 19STCV07941

NOW THEREFORE, IT IS MUTUALLY AGREED by and between the parties hereto as follows:

Section 3 of said Agreement No. 35733 is hereby amended to increase the total not-to-exceed amount to Five Hundred Fifty Thousand Dollars (\$550,000).
