FIRST AMENDMENT TO AGREEMENT NO. 30710

THIS FIRST AMENDMENT TO AGREEMENT NO. 30710 is made and entered, in duplicate, as of October 28, 2009, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 10, 2008, by and between TRANSTECH ENGINEERS, INC., a California corporation, with a place of business at 624 Brea Canyon Road, Walnut, California 91789 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with As-Needed Transportation Engineering, Transportation Planning, and Related Technical and Professional Services ("Project"); and

WHEREAS, City has selected Consultant in accordance with City's administrative procedures and City has determined that Consultant and its employees are qualified, licensed, if so required, and experienced in performing these specialized services; and

WHEREAS, City desires to have Consultant perform these specialized services, and Consultant is willing and able to do so on the terms and conditions in this Agreement; and

WHEREAS, the parties desire to reduce the amount of the Agreement by \$400,000;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and in this Amendment, the parties agree as follows:

1. Section 1.A. of Contract No. 30710 is amended in its entirety to read as follows:

"1. SCOPE OF WORK OR SERVICES.

A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay

for these services in the manner described below, not to exceed \$100,000, at the rates or charges shown in Exhibit "A"."

 Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 30710 are ratified and confirmed and shall remain in full force and effect.
