3 THIS THIRD AMENDMENT TO AGREEMENT NO. 35112 is made and
4 entered, in duplicate, as of November 11, 2021 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 9, 2021, by and between LONG BEACH COMMUNITY COLLEGE DISTRICT,
7 a community college duly organized and existing under the laws of the State of California
8 ("College"), whose address is 4901 E. Carson Street, O-5, Long Beach, California 90808,
9 and the CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City and College (the "Parties") entered into Agreement No.
11 35112 (the "Agreement") whereby College agreed to provide economic development
12 counseling and educational services through its Small Business Development Center; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 extend the term to June 30, 2020; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to extend the term to June 30, 2021; and

17 WHEREAS, the Parties desire to extend the term of the Agreement one (1)
18 additional one-year period;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
20 conditions herein contained, the Parties agree as follows:

21 1. Section 2 of the Agreement is hereby amended to read as follows:

22 "2. TERM. The term of this Agreement shall commence at midnight on
23 July 1, 2018, and shall terminate at 11:59 p.m. on June 30, 2022, unless sooner terminated
24 as provided in this Agreement, or unless the services or the Project is completed sooner.
25 The term may be extended for two (2) additional one-year periods, at the discretion of the
26 City Manager, and subject to the continued availability of funds."

27 2. Except as expressly modified herein, all of the terms and conditions
28 contained in Agreement No. 35112 are ratified and confirmed and shall remain in full force
