### GRANT AMENDMENT – NUMBER 1 GRANT CA0632B9D060802 Supportive Housing Program

This Amendment is made by and between the United States Department of Housing and Urban Development (HUD) and the City of Long Beach (the Grantee), whose business address is 2525 Grand Avenue, Long Beach, CA 90815 and whose Tax ID number is for Grant Number CA0632B9D060802. The Project is Permanent Housing and is located at 2200 Willard Street, Long Beach, CA.

#### **RECITALS**

- 1. HUD and the Grantee entered into SHP Grant Agreement CA0632B9D060802 on July 8, 2010 (the Grant Agreement). The Sponsor for the project was the PATH Ventures (PATH).
- 2. Under the terms of the grant, the grantee received \$650,823 to be used to carry out the project.
- 3. The grant term was for one year beginning November 1, 2010 and ending October 31, 2011.
- 4. By letter dated March 31, 2011, the Grantee requested that the grant be amended to incorporate revised budget line items that would better accommodate the remaining eight months in the grant period.
- 5. The project that is funded by grant CA0632B9D060802 will continue to provide the same services to the same number of clients.
- 6. HUD has reviewed the initial application and the proposed change and has determined that, with the change, the application ranking would have been high enough to be competitively selected in the year the application was initially selected.
- 7. The need for this project and the need for assistance to homeless persons continues within the jurisdiction where the project is located.
- 8. HUD has reviewed the project and has determined that it should be continued.

#### **AGREEMENTS**

The Grant Agreement is hereby amended as follows:

- 1. The revised and approved budget as reflected on Attachment A is incorporated into this agreement.
  - 2. This Amendment to the Grant Agreement constitutes the complete concurrence of the parties.
  - 3. The remaining terms of the Grant Agreement remain in full force and effect.
  - 4. This Amendment is effective on the day it is signed by the Director of Community Planning and Development for the HUD Los Angeles Field Office.
