

1 FIFTH AMENDMENT TO SUBCONTRACT NO. 30898

3 THIS FIFTH AMENDMENT TO SUBCONTRACT NO. 30898 FOR
4 VETERANS AND MENTAL HEALTH SERVICES (this "Subcontract") is made and
5 entered, in duplicate, as of June 6, 2012 for reference purposes only, pursuant to a
6 minute order adopted by the City Council of the City of Long Beach at its meeting on
7 August 14, 2007, by and between UNITED STATES VETERANS INITIATIVE, a
8 California nonprofit corporation ("Organization"), with offices located at 2001 River
9 Avenue, Long Beach, California 90810, and the CITY OF LONG BEACH, a municipal
10 corporation (the "City").

11 WHEREAS, the City has received monies from the County of Los Angeles
12 ("County") pursuant to Contract Number AO-08-060 for Homeless Veterans Initiative
13 ("County Contract") for a program that aims to develop a comprehensive service package
14 to improve and enhance specialized services for homeless veterans in the City; and

15 WHEREAS, as part of the County Contract, the City desires to enter into
16 subcontracts with certain organizations that provide veterans and mental health services
17 to homeless veterans in the City and Organization has been selected as a sub-recipient
18 of monies under the County Contract; and

19 WHEREAS, the parties entered Subcontract No. 30898 whereby
20 Organization agreed to provide these services to the City; and

21 WHEREAS, the parties desire to extend the term and specify the annual
22 disbursement amounts made to Organization;

23 NOW, THEREFORE, in consideration of the mutual terms and conditions in
24 Subcontract No. 30898 and herein, the parties agree as follows:

25 1. Section 3 of Subcontract No. 30898 is amended in its entirety to read
26 as follows:

27 "Section 3. The first year term of this Subcontract shall commence at
28 midnight on July 21, 2008 and shall terminate at 11:59 p.m. on July 20, 2009. The

1 second year term of this Subcontract shall commence at midnight on July 21, 2009 and
2 shall terminate at 11:59 p.m. July 20, 2010. The third year term of this Subcontract shall
3 commence at midnight on July 21, 2010 and shall terminate at 11:59 p.m. July 20, 2011.
4 The fourth year term of this Subcontract shall commence at midnight on July 21, 2011,
5 and shall terminate at 11:59 p.m. July 20, 2012. The fifth year term of this Subcontract
6 shall commence at midnight on July 21, 2012, and unless sooner terminated as provided
7 herein, shall terminate at 11:59 p.m. July 20, 2013.”

8 2. Section 4.B of Subcontract No. 30898 is amended in its entirety to
9 read as follows:

10 “4.B. Total disbursements made to Organization under this Subcontract by
11 the City shall not exceed One Hundred Thousand Dollars (\$100,000) per year over the
12 first year, second year and third year terms of this Subcontract. Total disbursements
13 made to Organization under this Subcontract by the City shall not exceed Seventy-Five
14 Thousand Dollars (\$75,000) for the fourth year and fifth year terms of this Subcontract.
15 These funds shall be used to provide services within the City. Upon execution of this
16 Subcontract, the City shall disburse the funds payable hereunder in due course of
17 payments following receipt from Organization of billing statements in a form approved by
18 the City showing expenditures and costs identified in Attachment “B” for the first year,
19 second year and third year terms of this Subcontract, and Attachment “B-1” for the fourth
20 year and fifth year terms of this Subcontract.”

21 3. Except as expressly amended herein, all terms and conditions in
22 Subcontract No. 30898 are ratified and confirmed and shall remain in full force and effect.




