

RESOLUTION NO. RES-18-0138

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH IN OPPOSITION TO PROPOSITION 6: VOTER APPROVAL FOR FUTURE GAS AND VEHICLE TAXES AND 2017 TAX REPEAL INITIATIVE WHICH WILL BE CONSIDERED STATEWIDE BY VOTERS ON THE NOVEMBER 6, 2018 BALLOT

WHEREAS, Proposition 6, the Voter Approval for Future Gas and Vehicle Taxes will appear on the November 6, 2018 statewide ballot; and

WHEREAS, Proposition 6 proposes to repeal Senate Bill (SB) 1 transportation revenue mechanisms imposed after January 1, 2017; and

WHEREAS, SB 1 transportation revenues represent 50 percent of all state funding received by the City for street and road improvements; and

WHEREAS, the City has over 1,000 centerline miles of Major, Minor and Alley roadways encompassing over 20 million square yards of asphalt, concrete and gravel surfacing, with asphalt accounting for approximately 90 percent of the paved area; and

WHEREAS, at an average replacement cost for a typical roadway just over \$2.8 million per mile, not including the value of the land, the City has over \$2.28 billion invested in its paved roadway network; and

WHEREAS, the preservation of existing roads and street systems has become a major activity for all levels of government; and

WHEREAS, the City is committed to maintaining a minimum of 15 percent of streets and roads as rated excellent; and

WHEREAS, the City's Pavement Management Plan demonstrates that an annual investment of \$28.5 million per year is needed to maintain current conditions of the City's major roadway network; and

1 WHEREAS, the City's Pavement Management Plan demonstrates that an
2 annual investment of \$70 million is needed to maintain current conditions of the City's minor
3 roadway network; and

4 WHEREAS, the City's Pavement Management Plan demonstrates that an
5 annual investment of \$6 million is needed to maintain current conditions of the City's alley
6 roadway network; and

7 WHEREAS, the Long Beach City Council, on May 22, 2018 adopted a
8 resolution approving the use of SB 1 funds totaling \$8 million in FY 19 for 11 repaving and
9 resurfacing projects Citywide; and

10 WHEREAS, funding for these projects in FY 19 will be lost if Proposition 6 is
11 approved by voters;

12 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
13 follows:

14 Section 1. The City Council hereby opposes Proposition 6, the Voter
15 Approval for Future Gas and Vehicle Taxes, which be presented to voters for
16 consideration on the November 6, 2018 statewide ballot.

17 Section 2. This resolution shall take effect immediately upon its adoption
18 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
