

1 SECOND AMENDMENT TO PERMIT NO. 30130

3 THIS SECOND AMENDMENT TO PERMIT NO. 30130 (the "Second
4 Amendment) is made and entered, in duplicate, as of May 4, 2016, for reference
5 purposes only, pursuant to a minute order adopted by the City Council of the City of Long
6 Beach at its meeting on May 23, 2006, by and between KEN WILLIAMS, an individual,
7 doing business as CALIFORNIA AQUATICS ("Permittee"), whose address is 1077 Pacific
8 Coast Hwy #190, Seal Beach, California 90740, and the CITY OF LONG BEACH, a
9 municipal corporation ("City").

10 WHEREAS, City and Permittee entered into Permit No. 30130 (the
11 "Permit"), pursuant to which City granted Permittee the permission to operate an aquatic
12 equipment rental concession; and

13 WHEREAS, on September 8, 2010, City and Permittee entered into a First
14 Amendment to the Permit (the "First Amendment") to extend the term to May 31, 2016;
15 and

16 WHEREAS, City and Permittee wish to exercise their second option to
17 extend the term of the Permit;

18 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
19 conditions herein contained, the parties agree as follows:

20 1. Section 2 of Permit No. 30130 is hereby amended in its entirety to
21 read as follows:

22 "2. TERM. The term of this Permit shall commence on June 1, 2006,
23 and shall terminate on May 31, 2018, unless revoked prior to said termination as
24 provided herein. Upon termination of this Permit (whether by lapse of time or otherwise),
25 Permittee shall quit and surrender possession of the premises and remove its personal
26 property therefrom."

27 2. Except as expressly modified herein, all of the terms and conditions
28 contained in Permit No. 30130 are ratified and confirmed and shall remain in full force




