A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH TO TEMPORARILY CLOSE AND REMOVE FROM PUBLIC USE CERTAIN STREETS. ALLEYS, AND WALKWAYS IN THE CITY OF LONG BEACH IN CONNECTION WITH THE CONDUCT OF THE 2015 FORMULA DRIFT PRO CHAMPIONSHIP

The City Council of the City of Long Beach resolves as follows:

Section 1. The City Council of the City of Long Beach finds and determines that the temporary closing of the streets, described herein, is necessary for the safety and protection of the participants and spectators in the 2015 Formula Drift Pro Championship to be held from April 10, 2015 through April 11, 2015.

Section 2. For the conduct of the 2015 Formula Drift Pro Championship, the following streets, alleys, and walkways are hereby temporarily closed for the periods stated:

- Α. On April 10, 2015 and April 11, 2015 from 7:00 a.m. to 7:00 p.m., Seaside Way from Pine Avenue to eastern end of Seaside Way, Linden Avenue from Ocean Boulevard to Seaside Way, Marine Way from Locust Avenue to Collins Way, Atlantic Way from Ocean Boulevard to Seaside Way, Marine Way from Hart Place to eastern end, Linden Avenue, northbound and southbound from Shoreline Drive to Marina Parking lot, and Locust Avenue from Ocean Boulevard to Seaside Way.
- B. On April 10, 2015 and April 11, 2015 from 7:00 a.m. to 7:00 p.m., Shoreline Drive westbound from Ocean Boulevard and Alamitos intersection to Shoreline Village Drive.

- C. On April 10, 2015 and April 11, 2015 from 7:00 a.m. to 7:00 p.m., Shoreline Drive eastbound from Shoreline Village Drive to Ocean Boulevard and Alamitos intersection.
- On April 10, 2015 and April 11, 2015 from 7:00 a.m. to 7:00 D. p.m., walkway off of Seaside Way from Hart Place to the east end of Seaside Way.

The temporary closing of the above streets, alleys, and Section 3. walkways, for the times herein provided is necessary for the safety and protection of the participants and spectators in the 2015 Formula Drift Pro Championship and qualifying events to be held from April 10, 2015 through April 11, 2015, utilizing the streets described herein.

For the period April 10 and 11, 2015 from 7:00 a.m. to 7:00 Section 4. p.m., the streets, alleys and walkways described in Section 2.A. are hereby withdrawn and removed from public use.

For the period April 10 and 11, 2015 from 7:00 a.m. to 7:00 Section 7. p.m., the streets, alleys and walkways described in Section 2.D. are hereby withdrawn and removed from public use.

Section 8. The City Manager, or his designee, is authorized and directed to post notices of the intent to temporarily reduce lanes, close the streets, alleys, walkways described in Sections 2, 3, 4, 5, 6, and 7 above at least twenty-four (24) hours prior to the closure thereof.
