3 THIS FIRST AMENDMENT TO CONTRACT NO. 34139 is made and
4 entered, in duplicate, as of September 21, 2016, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 October 13, 2015, by and between EDWARD WHITE & CO., LLP, a California limited
7 liability partnership, Certified Public Accountants, whose business address is 21700
8 Oxnard Street, Suite 400, Woodland Hills, California 91367 ("Contractor"), and the CITY
9 OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City and Contractor entered into Contract No. 34139 (the
11 "Contract") whereby Contractor agreed to perform an Article 9 review of oil company
12 records; and

13 WHEREAS, City and Contractor wish to exercise their first option to extend
14 the term;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the parties agree as follows:

17 1. Section 3 of the Contract is hereby amended to read as follows:

18 "3. TERM. The term of this Contract shall commence on December 1,
19 2015 and shall terminate on November 30, 2017, unless terminated earlier pursuant to
20 Section 7. City has the option to extend the term for one (1) additional one-year period."

21 2. Except as expressly modified herein, all of the terms and conditions
22 contained in Contract No. 34139 are ratified and confirmed and shall remain in full force
23 and effect.
