3 THIS SECOND AMENDMENT TO AGREEMENT NO. 33841 is made and
4 entered, in duplicate, as of January 31, 2019 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April
6 7, 2015, by and between KIMLEY-HORN AND ASSOCIATES, INC., a North Carolina
7 corporation (“Consultant”), with a place of business at 660 S. Figueroa Street, Suite 2050,
8 Los Angeles, California 90017, and the CITY OF LONG BEACH, a municipal corporation
9 (“City”).

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed traffic engineering, transportation planning and
12 related technical and professional services; and

13 WHEREAS, City and Consultant (the “Parties”) entered into Agreement No.
14 33841 (the “Agreement”) whereby Consultant agreed to provide these services; and

15 WHEREAS, the Parties entered into a First Amendment to the Agreement to
16 extend the term to May 31, 2019; and

17 WHEREAS, the Parties desire to extend the term one (1) additional one-year
18 period;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
20 conditions herein contained, the Parties agree as follows:

21 1. Section 2 of the Agreement is hereby amended to read as follows:

22 “2. TERM. The term of this Agreement shall commence at midnight on
23 June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2020, unless sooner terminated
24 as provided in this Agreement, or unless the services or the Project is completed sooner.”

25 2. Except as expressly modified herein, all of the terms and conditions
26 contained in Agreement No. 33841 are ratified and confirmed and shall remain in full force
27 and effect.
