SECOND AMENDMENT TO AGREEMENT NO. 32747

THIS SECOND AMENDMENT TO AGREEMENT NO. 32747 is made and entered, in duplicate, as of September 11, 2014 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 4, 2012, by and between AARDVARK, a California corporation, with a place of business at 1935 Puddington Drive, LaVerne, California 91750 ("Vendor"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 32747 whereby Vendor agreed to furnish and deliver less lethal munitions; and

WHEREAS, the parties desire to increase the Agreement amount by \$50,000 and extend the term;

NOW THEREFORE, in consideration of the mutual terms and conditions in the Agreement and in this Second Amendment, the parties agree as follows:

1. Section 1. of Agreement No. 32747 is amended in its entirety to read as follows:

"1. 2nd renewal option extending term to September 11, 2015".

2. Section 2. of Agreement No. 32747 is amended in its entirety to read as follows:

"2. \$50,000.00 has been added for 2nd renewal option for a new not to exceed total of \$300,000.00."
