HONORABLE MAYOR AND CITY COUNCIL City of Long Beach California

RECOMMENDATION:

Adopt the attached Resolution directing the Los Angeles County Auditor-Controller to include on the 2012-13 Secured Tax Roll, certain levies made pursuant to the provisions of the Long Beach Municipal Code for weed and debris removal, administrative citations, securing of buildings, and vacant buildings in the amount of \$220,759. (Citywide)

DISCUSSION

The attached Resolution authorizes the City to collect delinquent weed removal charges and/or delinquent building abatement charges, vacant building monitoring fees, incidental enforcement costs, interest, and lien transfer charges from the responsible owners through their property tax bills for properties cleaned, abated and/or monitored during July 1, 2011 through June 30, 2012. Interest accrues at the rate of 12 percent from the delinquency date through June 30, 2012. In June 2011, City Council amended administrative citations to allow interest to accrue at the same rate.

The City is authorized to undertake enforcement activities, assess levies for delinquent charges and accrue interest by Long Beach Municipal Code (LBMC) Chapters 8.56, 9.65, 18.20, and 18.21, following the specified notification and appeal process. The interest rate charged is cited in LBMC Sections 8.56.130, 9.65.140, 18.21.040, and 18.20.210.

Upon approval by the City Council, the Department of Financial Management will forward the authorizing Resolution and the prescribed reporting forms to the Los Angeles County Auditor-Controller, Tax Division, for incorporation into the 2012-13 County Secured Tax Roll.

Total code enforcement delinquency charges to be placed on the 2012-2013 tax roll are \$220,759, representing 112 properties. Unless noted, all delinquent charges relate to the Code Enforcement Division of the Neighborhood Services Bureau in the Development Services Department. These are comprised of:

- a) Weed removal and cleaning charges including interest in the amount of \$37,892.55 levied against the 16 listed properties (see Resolution Exhibit A);
- b) Administrative citation charges including interest in the amount of \$133,828.57 levied against the 79 listed properties (see Resolution Exhibit B), of which three of those properties relate to the Building Bureau as identified;
- c) Secure building and demolition charges including interest in the amount of \$4,148.55 levied against the two listed property (see Resolution Exhibit C); and,
- d) Vacant building charges including interest in the amount of \$44,889.33 levied against the 15 listed properties (see Resolution Exhibit D).

This matter was reviewed by Assistant City Attorney Mike Mais on June 28, 2012 and Budget Management Officer Victoria Bell on July 3, 2012.

TIMING CONSIDERATIONS

City Council action on this item is requested on July 24, 2012, as the Los Angeles County Auditor-Controller requires receipt of the authorized lien assessment on July 31, 2012.

FISCAL IMPACT

The County will be requested to collect \$220,759 with the annual property taxes for deposit into the General Fund (GP) in the Development Services Department (DV). There is no local job impact associated with this recommendation.

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DIRECTING THE LOS ANGELES COUNTY AUDITOR-CONTROLLER TO INCLUDE ON THE **ROLL** 2012-2013 **SECURED** TAX CERTAIN ASSESSMENTS MADE PURSUANT TO PROVISIONS OF THE LONG BEACH MUNICIPAL CODE FOR WEED **ADMINISTRATIVE CITATIONS** AND ABATEMENT. OF DEMOLITION AND SECURING PENALTIES, BUILDINGS, AND MONITORING OF VACANT BUILDINGS

WHEREAS, Chapters 8.56 (Weed Removal), 9.65 (Administrative Citations and Penalties), 18.20 (Unsafe Buildings or Structures), and 18.21 (Maintenance of Long-Term Boarded and Vacated Buildings) of the Long Beach Municipal Code provide a system for the City to levy, collect and recover costs associated with removing weeds and debris from privately owned real property, unpaid administrative citations and penalties, securing of buildings, and monitoring of vacant buildings; and

WHEREAS, the City's Building Official is required to certify to the City

Treasurer-Tax Collector the amount of the weed abatement, unpaid administrative
citations and penalties, securing of buildings, and monitoring of vacant buildings; and

WHEREAS, the City's Building Official has certified to the City Treasurer-Tax Collector unpaid charges in connection with the weed abatement, administrative citations and penalties, securing of buildings, and monitoring of vacant buildings which should be entered upon the secured tax roll and collected in the same manner as ad valorem taxes.

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

The Los Angeles County Auditor-Controller is hereby Section 1. authorized and requested to include on the 2012-2013 secured tax roll the delinquent assessment charges, and penalties, if any, for each of the described parcels of real property set forth in Exhibits "A", "B", "C", and "D" attached hereto and made a part hereof. The county parcel number and the total unpaid assessment, together with interest thereon, and the situs address of the real property are set forth on each exhibit. Only the amount set forth in the third column entitled "Amount" should be entered as charges due the City of Long Beach on the real property to which the amount refers. The Los Angeles County Auditor-Controller is directed to collect said charges in the same manner as ad valorem taxes.

Section 2. The Director of Financial Management is directed to transmit to the County Auditor-Controller a certified copy thereof on or before July 31, 2012.

This resolution shall take effect immediately upon its Section 3. adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
