3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH DECLARING THE RESULTS OF
5 THE CITY'S GENERAL MUNICIPAL ELECTION HELD ON
6 TUESDAY, JUNE 8, 2004, FOR THE PURPOSE OF
7 ELECTING A MEMBER OF THE CITY COUNCIL FROM
8 COUNCIL DISTRICT NUMBER 8, AND DIRECTING THE
9 CITY CLERK TO ISSUE A CERTIFICATE OF ELECTION
10 TO THE CANDIDATE DECLARED TO HAVE BEEN
11 ELECTED AT THE GENERAL MUNICIPAL ELECTION

13 The City Council of the City of Long Beach does resolve, determine, order
14 and declare as follows:

15 Section 1. That the General Municipal Election for the purpose of electing
16 a candidate as required by law for the office of Member of the City Council from the
17 Eighth Council District was duly held on Tuesday, June 8, 2004, and the votes cast,
18 including the absent voter ballots issued in connection with the election which were
19 returned, were all duly and regularly canvassed by the City Clerk, who has filed a
20 Certificate of Canvass with the City Council. From that certification and return the City
21 Council finds and determines that the total number of votes cast in the district, the total
22 number of votes cast in each of the respective election precincts established for the
23 election, the number of votes cast for each candidate in each precinct and the total
24 number of votes for each candidate are as provided in Exhibit "A" attached to and made
25 a part of this resolution.

26 Sec. 2. That the candidates nominated as required by law for the
27 office of Member of the City Council from the Eighth District, and the names of the
28 persons voted for at the election, were:

The City Clerk is directed to issue Rae M. Gabelich a Certificate of Election certifying to the election to this office for such term.

Sec. 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.


