PURCHASE AGREEMENT

9 WHEREAS, City requested proposals from persons and entities in the 10 business of providing handheld computerized parking citation devices and Seller 11 responded; and

WHEREAS, City has determined that Seller best meets City's needs and
 requirements, and wishes to purchase these devices from Seller which Seller is willing and
 able to sell to City;

For and in consideration of the mutual terms and conditions in this Agreement, the parties agree as follows:

17 1. <u>Devices</u>. Seller shall provide the devices, as and when ordered by the 18 City, in accordance with Seller's Proposal attached as Exhibit "A" and incorporated by this 19 reference. If there is any conflict between Exhibit "A" and Exhibit "B", then Exhibit "A" shall 20 govern.

2. <u>Purchase Price</u>. City shall pay for the devices in accordance with the
 "Base Solution Purchase Pricing" attached as Exhibit "B." and incorporated by this
 reference, not to exceed \$350,000.00 including tax. City reserves the right to purchase
 only those items that meet its needs and requirements. City is exempt from payment of
 Federal Excise Tax under Certificate No. 95-730502K and none shall be charged.

3. <u>Term</u>. The term of this Agreement shall begin at 12:01 a.m. on
 September 5, 2006, and shall end when the warranties on the devices has expired or on
 August 31, 2007, whichever is later.

4. Warranty. Seller warrants the devices as described in Exhibit "B".

5. <u>Notice</u>. Notice shall be in writing and personally delivered or deposited in the U.S. Postal Service, first class, registered or certified, return receipt, postage prepaid, to Seller at the address first stated above, and to City at 333 West Ocean Boulevard, Long Beach, California 90802 Attn: City Manager. Notice shall be deemed given on the date of personal delivery or on the date shown on the return receipt, whichever occurs first. Notice of change of address shall be given as other notices.

6. <u>Assignment</u>. Seller shall not, except for moneys due and payable under this Agreement, assign its rights or delegate its duties under this Agreement, or any interest in the Agreement, or any portion of it, without the prior written approval of City. Any attempted assignment or delegation shall be void, and any assignee or delegate shall acquire no right or interest by reason of the attempted assignment or delegation. Furthermore, Seller shall not subcontract any portion of its performance without the prior written approval of City.

7. <u>Miscellaneous</u>. A. This Agreement was created as a joint effort of both
 parties and neither it nor any part of it shall be construed against one party as the drafter.

B. This Agreement, including Exhibits, shall not be amended, nor any
 provision or breach waived except in a writing signed by the parties which expressly refers
 to this Agreement.

C. This Agreement shall be governed by and construed pursuant to the laws
 of the State of California (except those provisions of California law pertaining to conflicts
 of laws). Any action involving this Agreement shall be brought in the Los Angeles County
 Superior Court, Long Beach Judicial District.

D. This Agreement, including Exhibits, constitutes the entire understanding between the parties and supersedes all other agreements, oral or written, or preprinted terms and conditions of the Purchase Order to the extent they are inconsistent with this Agreement, with respect to the subject matter of this Agreement.

E. In the event of any conflict or ambiguity between this Agreement and any

 Agreement shall govern.

F. If there is any legal proceeding between the parties to enforce or interpret
this Agreement or to protect or establish any rights or remedies under it, the prevailing
party shall be entitled to its costs, including reasonable attorney's fees.

G. The acceptance of any services or the payment of any money by City
shall not operate as a waiver of any provision of this Agreement, or of any right to damages
or indemnity stated in the Agreement. The waiver of any breach of this Agreement shall
not constitute a waiver of any other or subsequent breach of this Agreement.

H. Termination of this Agreement shall not affect rights or liabilities of the
 parties which accrued prior to termination and shall not extinguish any warranties.

I. Seller shall not use the name of City, its officials or employees in any
 advertising or solicitation for business nor as a reference without the prior written approval
 of City's City Manager.

J. This Agreement is intended by the parties to benefit themselves only and is not in any way intended or designed to or entered for the purpose of creating any benefit or right for any person or entity of any kind that is not a party to this Agreement.

K. Seller is and shall act as an independent contractor and neither Seller nor
 its employees, agents, suppliers, or subcontractors shall act as or be deemed employees,
 representatives or agents of City.

L. Seller shall comply with all applicable federal, state and local laws and regulations during its performance.

M. The terms and conditions of this Agreement are severable. If any term
 or condition is held invalid, void or unenforceable, the remaining terms and conditions shall
 be given effect.

N. The division of provisions of this Agreement into sections and the captions
on those sections is for convenience only and shall not be considered in construing this
Agreement.


