

FIRST AMENDMENT TO RIGHT OF ENTRY PERMIT NO. P-00037

P-00037

THIS FIRST AMENDMENT TO RIGHT OF ENTRY PERMIT NO. P-00037 is made and entered into as of May 17, 2018 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 16, 2015, by and between the CITY OF LONG BEACH, a municipal corporation ("City") and CALIFORNIA STATE UNIVERSITY, LONG BEACH ("Permittee").

WHEREAS, City and Permittee entered into Right-of-Entry Permit No. P-00037 dated as of June 17, 2015, pursuant to which City granted Permittee the non-exclusive right to enter City-owned property solely for the purpose of conducting academic research activities, including fish tagging, monitoring, data collection, and installing RFID tag readers and receptor devices on the Colorado Lagoon and Marine Stadium culvert headwalls; and

WHEREAS, City and Permittee desire to amend the Permit by exercising their option to extend the term one (1) additional two-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 2.A of Permit No. P-00037 is hereby amended to read as follows:

"A. Permission to enter shall begin on June 1, 2015, and continue through June 1, 2020, unless sooner terminated as provided in this Permit, or unless the activities to be conducted hereunder are completed sooner."

2. Except as expressly modified herein, all of the terms and conditions contained in Permit No. P-00037 are ratified and confirmed and shall remain in full force and effect.
