A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DESIGNATING THE BALLOT LISTING OF THE CANDIDATES WHICH HAVE BEEN NOMINATED FOR THE CITY'S PRIMARY NOMINATING ELECTION ON TUESDAY, APRIL 11, 2006

WHEREAS, in accordance with the Long Beach City Charter the City Council has called a municipal primary nominating election for the City Council offices in Council Districts One, Three, Five, Seven and Nine and the offices of Mayor; City Attorney; and City Auditor to be held in the City of Long Beach on April 11, 2006; and

WHEREAS, in accordance with City Charter Section 1907, the City Clerk has submitted to the City Council a certified list of the candidates which have been duly nominated as required by law for the elective offices to be voted on at said election, and the names are listed for each such office in the order of the randomized alphabet selected by the Secretary of State in a drawing held on January 19, 2006 pursuant to California Elections Code Section 13112;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:
