3 THIS FIRST AMENDMENT TO AGREEMENT NO. 31591 is made and
4 entered, in duplicate, as of May 2, 2012 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 September 1, 2009, by and between WIDOM WEIN COHEN O'LEARY TERASAWA
7 (WWCOT), a California corporation ("Consultant"), with a place of business at 3130
8 Wilshire Blvd., 6th Floor, Santa Monica, California 90409, and the CITY OF LONG
9 BEACH, a municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with As-Needed Architectural Services with Expertise in
12 Sustainable and LEED-Certified Designs ("Project"); and

13 WHEREAS, the parties entered Agreement No. 31591 whereby Consultant
14 agreed to perform such services; and

15 WHEREAS, the parties desire to extend the term; and

16 NOW, THEREFORE, in consideration of the mutual terms and conditions in
17 Agreement No. 31591 and in this First Amendment, the parties agree as follows:

18 1. Section 2 of Agreement No. 31591 is hereby amended to read as
19 follows:

20 "2. TERM. The term of this Agreement shall commence at midnight on
21 April 5, 2010, and shall terminate at 11:59 p.m. on April 4, 2013, unless sooner
22 terminated as provided in this Agreement, or unless the services or the Project is
23 completed sooner."

24 2. Except as expressly amended in this First Amendment, all terms and
25 conditions in Agreement No. 31591 are ratified and confirmed and shall remain in full
26 force and effect.


