3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH IMPOSING A CHARGE OF  
5 TWENTY-FIVE PERCENT (25%) ON EACH UNPAID  
6 PENALTY FOR A PARKING VIOLATION SENT TO ACS  
7 STATE & LOCAL SOLUTIONS, INC. ("ACS") FOR  
8 COLLECTION

10 WHEREAS, there are certain penalties for parking citations that cannot be  
11 collected for the City by the California Department of Motor Vehicles; and

12 WHEREAS, ACS is able and desire to collect these penalties on behalf of  
13 the City and the City desires ACS to do so; and

14 WHEREAS, the City also desires to recapture its cost for collection by the  
15 imposition of a charge for collection; and

16 WHEREAS, prior to adoption of this resolution, public notice was given and  
17 a hearing held in accordance with the California Government Code;

18 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
19 follows:

20 Section 1. That the above recitals are true and correct and are  
21 incorporated herein by this reference.

22 Section 2. There is hereby imposed a charge of twenty-five percent  
23 (25%) on any unpaid penalty relating to a parking violation when the City submits the  
24 unpaid penalty to ACS for collection. This charge shall be added to the unpaid penalty  
25 prior to submittal to ACS for collection. However, the City's Director of the Department of  
26 Financial Management or designee may waive all or part of the twenty-five percent (25%)  
27 charge as part of negotiated settlements where the penalties are less than \$1,000.00.

28 Section 3. This resolution shall take effect immediately upon its adoption


1 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
