

RESOLUTION NO. C-

A RESOLUTION OF THE CITY COUNCIL OF
THE CITY OF LONG BEACH AMENDING THE LONG
BEACH MARINA RULES AND REGULATIONS' FEES,
RATES AND CHARGES FOR FISCAL YEAR 2004-2005

WHEREAS, the City Council of the City of Long Beach adopted Resolution No. C-28082 on September 10, 2002 amending the attachment to Marina Rules and Regulations, which provides for fees, rates and charges relating to the use of the City's marinas; and

WHEREAS, the City Council desires to amend Resolution No. C-28082 with respect to fees, rates and charges; and

WHEREAS, prior to adoption of this resolution, public notice and hearing have been given in accordance with Section 66018 of the California Government Code;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. Section "N", Marina Slip Permit Fees, is amended to read as follows:

"N. Marina Slip Permit Fee [Long Beach Municipal Code Section 16.08.900A]: Marina Slip Permit Fees are due and payable on the 1st day of each month, whether or not a bill is received by Permittee. If payment is not received by the 10th of the month, a second bill will be sent to the Permittee, and a penalty will be assessed as provided in Section 16.08.980 of the Long Beach Municipal Code. Permittee shall pay the permit fees and penalty by the date specified on the pending cancellation notice and any failure to make the payment when due will result in cancellation of the permit. Permittee shall pay an annual slip fee adjustment equal to the annual percentage change in the April Consumer Price Index ("CPI - All

1 Urban Consumers) for the Los Angeles-Anaheim-Riverside Region. Adjusted rates
2 shall be increased up to the nearest five-cent increment. Adjustments shall
3 automatically become effective on the first day of October each year without
4 amendment to the resolution or any other action by the City. The rate change
5 based on the CPI is to be effective beginning October 1, 2003.

18 **OTHER FEES FOR ALL MARINAS**

19 **Permanent End Tie Slip Fee:** 1.1 times the regular slip permit fee with a one-year
 20 agreement.

21 **Personal Watercraft Slip Fee:** \$4.25 per foot with a minimum ten-foot agreement.

22 **Commercial Slip Fee:** Except as otherwise provided in permits or other
 23 agreements approved by the City Council, 1.2 times the applicable per foot rate for vessels
 24 assigned to commercial floats (as defined in Section III.M.)

25 **Multi-Hull Slip Fee:** 1.3 times current single slip fees if berthed in a slip. Berthing
 26 of multi-hull vessels in slips is only applicable in the Downtown Marina and when the
 27 marina is not at full capacity. If a multi-hull vessel is berthed on an end-tie in either marina,
 28 the regular slip permit fee will apply.
