The City Manager of the City is hereby authorized to enter an agreement with Los Angeles Truck Centers, LLC dba Los Angeles Freightliner Western Star – Whittier to purchase one (1) liquefied natural gas powered side loader refuse trucks of substantially the same type and kind purchased by the State of California-Department of Transportation pursuant to the State PO except as modified by mutual agreement of the City and Los Angeles Truck Centers, LLC dba Los Angeles Freightliner Western Star – Whittier, and the purchase by the City shall be on the same terms and conditions afforded to the State of California-Department of Transportation in an amount not to exceed \$245,435, including tax and shipping, for a period extending until the warranty on the Refuse Truck expires.
- 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
