SUBJECT: Authorization to Fund Community Projects Under the Neighborhood

Partners Program (Districts 1, 2, 4, 6, and 9)

DISCUSSION

The Neighborhood Partners Program (NPP) is a continuing program offered by the Department of Community Development to assist neighborhood/community groups within designated Community Development Block Grant (CDBG) target zones to accomplish neighborhood beautification and improvement projects. Eligible groups must be formally established organizations with designated officers, membership rosters, and a history of neighborhood involvement. The NPP provides matching grants of up to \$5,000 in goods and services to accomplish approved projects. The match provided by the applicant must be equal to at least 50 percent of the total project cost and may be supplied in the form of cash, goods and services, and volunteer work hours. (Volunteer work hours may not be the sole match.)

Notices of funding availability were sent to over 150 community groups and neighborhood associations within the CDBG target zones on July 1, 2004. Eight proposals were received in the competition for funds. A special committee of the Community Development Advisory Commission (CDAC) reviewed and ranked each application based upon pre-established criteria that emphasized positive neighborhood improvement projects. At its November 17, 2004 meeting, CDAC unanimously voted to recommend all eight proposals for funding. A summary of the applications received and funding requests/recommendations is attached. The recommended funding level is \$31,531.92.
