

1 FIRST AMENDMENT TO AGREEMENT NO. 34674

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34674 is made and
4 entered, in duplicate, as of December 21, 2017, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on July
6 11, 2017, by and between CSG CONSULTANTS, INC., a California corporation
7 ("Consultant"), with a place of business at 3707 West Garden Grove Boulevard, Suite 100,
8 Orange, California 92868, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed plan review and inspection services; and

12 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
13 34674 (the "Agreement") whereby Consultant agreed to provide these services; and

14 WHEREAS, the Parties desire to increase the Agreement amount by
15 \$120,000 for a total not to exceed amount of \$200,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the Parties agree as follows:

18 1. Section 1.A. of the Agreement is hereby amended to read as:

19 "A. Consultant shall furnish specialized services more particularly
20 described in Exhibit "A", attached to this Agreement and incorporated by this
21 reference, in accordance with the standards of the profession, and City shall pay for
22 these services in the manner described below, not to exceed Two Hundred
23 Thousand Dollars (\$200,000), at the rates or charges shown in Exhibit "B".

24 2. Except as expressly modified herein, all of the terms and conditions
25 contained in Agreement No. 34674 are ratified and confirmed and shall remain in full force
26 and effect.
