WHEREAS, in accordance with the Long Beach City Charter the City  
Council has called a special municipal election for Member of the City Council for  
Council District Six, to be held in the City of Long Beach Councilmanic District 6 on  
May 1, 2007; and

WHEREAS, in accordance with City Charter Section 1907, the City Clerk
