A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO CONTRACT NO. 34014 WITH ATLANTIC MACHINERY, INC. FOR THE PURCHASE OF TWO (2) ADDITIONAL SCHWARZE MODEL A7000 CNG REGENERATIVE AIR SWEEPERS WITH RELATED EQUIPMENT AND ACCESSORIES, THROUGH THE NATIONAL JOINT POWERS ALLIANCE (NJPA)

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City and Atlantic Machinery entered into Contract No. 34014 pursuant to Resolution No. RES-15-0076; and

WHEREAS, the City desires to purchase two (2) additional Schwarze model A7000 CNG Regenerative air sweepers, with related equipment and accessories, from Atlantic Machinery, under National Joint Powers Alliance (NJPA) Contract No. 022014;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. The City Manager of the City is hereby authorized to execute an amendment to Contract No. 34014 with Atlantic Machinery, Inc. for the purchase of two (2) additional A7000 CNG regenerative air sweepers, with related equipment and

1 accessories, of the same type and kind identified in the NJPA Contract in an amount not  
2 to exceed Six Hundred Thirty-Eight Thousand Seven Hundred Sixty-Four Dollars  
3 (\$638,764), including tax, on the same terms and conditions as the NJPA Contract, for a  
4 total contract amount not to exceed One Million Nine Hundred Sixteen Thousand Two  
5 Hundred Ninety-Two Dollars (\$1,916,292).

6 Section 3. This resolution shall take effect immediately upon its adoption  
7 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
