WHEREAS, the parties desire to extend the term and increase the Agreement amount by \$293,600 for a total not to exceed amount of \$2,125,000;

Section 1.A. of Agreement No. 32027 is hereby amended to read as 1. follows:

"1. SCOPE OF WORK OR SERVICES.

Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Two Million One Hundred Twenty-Five Thousand Dollars (\$2,125,000), at the rates or charges shown in Exhibit "B"."

- Section 2 of Agreement No. 32027 is hereby amended to read as 2. follows:
 - "2. TERM. The term of this Agreement shall commence at midnight on
