AMENDMENT TO THE CONTINUUM OF CARE GRANT AGREEMENT FOR

This Amendment to Grant Agreement is made by and between the United States Department of Housing and Urban Development (HUD) and City of Long Beach CA 606, (the Recipient), of 2525 Grand Avenue, Room 235, Long Beach, CA 90815.

RECITALS

1. HUD and the Recipient entered into a Grant Agreement dated **October 14, 2014**, having Grant No. CA0000U9D061301 (the Grant Agreement).
2. At the receipt of Unified Funding Agency (UFA) status for FY 2013, the Recipient consolidated all grants to end on June 30, 2015. However, the Grant Agreement ends on January 31, 2015. At the expiration of the Grant Agreement, the Recipient does not expect to have enough funds remaining in its grant account to extend and operate all projects. HUD and the Recipient are desirous of allowing the Recipient to obtain funds from HUD in order for all projects to be able to operate until June 30, 2015.

AGREEMENTS

The Grant Agreement is hereby amended as follows:

1. The term of the Grant Agreement is extended through June 30, 2015.
2. As of the date this this amendment is executed, HUD's total funding obligation for this grant is hereby amended to be \$6,691,652, allocated as follows:


