FORTIETH AMENDMENT TO LIGHTING CONTRACT NO. 24289

**24289**

THIS FORTIETH AMENDMENT is made and entered, in duplicate, as of November 10, 2016 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on November 21, 1995, by and between WS LIGHT & POWER, INC., a California corporation ("WS"), assignee of CITY LIGHT & POWER, INC., a California corporation ("CLP"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Lighting Contract No. 24289 whereby CLP agreed to convert the City's Street Light System; and

WHEREAS, said Contract included a provision whereby the City could choose to install, relocate or remove lighting and WS would do so; and

WHEREAS, the City desires WS to perform such additional work as provided in the Contract;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained in Lighting Contract No. 24289 and herein, the parties agree as follows:

1. Section 69 of Lighting Contract No. 24289 is hereby added to read as follows:

"69. ELM AVENUE Z-PATTERN FESTIVAL LIGHTING.

69.1 Scope of Work. WS shall furnish labor, material and equipment to install festival lighting on Elm Avenue between 3rd Street and 4th Street, more particularly described in the proposal attached hereto as Exhibit "QQ", attached hereto and incorporated herein.

69.2 Compensation. For the services and work relating to the Elm Avenue Z-Pattern Festival Lighting, City shall pay WS upon completion of the services, an amount not to exceed Thirteen Thousand Four Hundred Eighty-Five Dollars (\$13,485).

69.3 Conditions. To the extent applicable, any and all terms and conditions relating to the Street Lighting System in Lighting Contract No. 24289, including all exhibits,


1 shall apply to the Elm Avenue Z-Pattern Festival Lighting.”

**RE: Elm Avenue Z-Pattern Festival Lighting Rev. 1**

Dear Mr. Hoey:

City Light & Power, Inc. (CLP) is pleased to submit a proposal to install festival lighting on Elm Ave. between 3<sup>rd</sup> Street and 4<sup>th</sup> Street as described below.

CLP will install three spans of aircraft cable, festival lighting strands with suspended sockets and T-50 LED bulbs from an existing street light on the northeast corner of 3<sup>rd</sup> St. & Elm to the traffic signal pole on the southwest corner of 4<sup>th</sup> St. & Elm. CLP will require approval to make the attachment to this traffic signal pole. Once the installation is complete, CLP will energize the lights to ensure all the lamps are illuminated and working properly. To supply power to these lights, CLP will have to pull a new circuit (approximately 340 LF) from an existing LS-3, metered service located on the south side of 4<sup>th</sup> St. at Frontenac Ct. This service does not currently have connectivity to the street lights on Elm Ave., therefore, CLP will be installing new conduit (approximately 170 LF) from the corner of 4<sup>th</sup> St. and Elm, on the east side of Elm Ave., south to the first street light on Elm Ave. This will be done in conjunction with the current sidewalk repair project on Elm Ave. which will avoid having to install the conduit by open trench or boring methods. CLP will then install a receptacle at this pole where the festival lighting will be connected.

Total cost for this project is **Thirteen Thousand Four Hundred Eighty-Five Dollars (\$13,485).**



