

SECOND AMENDMENT TO AGREEMENT NO. 36156

THIS SECOND AMENDMENT TO AGREEMENT NO. 36156 is made and entered, as of May 8, 2023 for reference purposes only, pursuant to minute order adopted by the City Council of the City of Long Beach at its meeting on October 5, 2021, by and between the LOS CERRITOS WETLANDS STEWARDSHIP, INC., a California corporation ("Contractor"), with a place of business at 6289 E. Pacific Coast Highway, Long Beach, California 90803 and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 36156 (the "Agreement") whereby Contractor agreed to provide specialized services requiring unique skills to be performed in connection with maintenance and management of environmentally sensitive areas along the tidelands areas and environmental tasks, including interpretive education, coordination of volunteer groups, and bird surveying counting for various tidelands areas ("Project"); and

WHEREAS, the Parties entered into a First Amendment to clarify the annual not to exceed amount of Six Hundred Ninety-Nine thousand Six Hundred Sixty Dollars (\$699,660); and

WHEREAS, the Parties desire to extend the term for an additional one (1) year period until June 30, 2024;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

"A. Contractor shall furnish specialized services more particularly described in Exhibit "A-2", attached to the Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an annual amount not to exceed Six Hundred Ninety-Nine Thousand Six Hundred Sixty Dollars (\$699,660), at the rates or charges shown in Exhibit "B".

- 2                   “TERM. The term of this Agreement shall commence at midnight on July 1,
- 3 2021, and shall terminate at 11:59 p.m. on June 30, 2024, unless sooner terminated as
- 4 provided in this Agreement, or unless the services or the Project is completed sooner. The
- 5 term may be extended for two (2) additional one-year periods, at the discretion of the City
- 6 Manager.”
- 7                   3.      Except as expressly modified herein, all of the terms and conditions
- 8 contained in Agreement No. 36156 are ratified and confirmed and shall remain in full force
- 9 and effect.
