ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY AMENDING SECTION 10.14.020, SUBSECTION A, RELATING TO TRAFFIC OPERATIONS

Pursuant to action taken on September 5, 2006, the City Council of the City of Long Beach ordains as follows:

Section 1. Section 10.14.020.A of the Long Beach Municipal Code is hereby amended by amending Subsection 15 to read as follows:

15. (Westbound) West Fifty-First Street, between a point three hundred feet (300') west of Long Beach Boulevard and Pacific Avenue,

Sec. 2. The City Clerk shall certify to the passage of this ordinance by the City Council of the City of Long Beach and cause it to be posted in three conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first day after it is approved by the Mayor.
