FIRST AMENDMENT TO AGREEMENT NO. 32758

THIS FIRST AMENDMENT TO AGREEMENT NO. 32758 is made and entered, in duplicate, as of April 24, 2013 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on February 7, 2012, by and between RRM DESIGN GROUP, a California corporation, with a place of business at 232 Avenida Fabricante, Suite 112, San Clemente, California 92672 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with on-call planning services ("Project"); and

WHEREAS, the parties entered Agreement No. 32758 whereby Consultant agreed to provide these Services; and

WHEREAS, the parties desire to amend the term of the Agreement to include two (2) annual renewal options; and

WHEREAS, the parties desire to exercise the first renewal option to extend the term by an additional one (1) year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 2 of Agreement No. 32758 is hereby amended to read as follows:
- "2. The initial term of this Agreement shall commence at TERM. midnight on January 1, 2012, and shall terminate at 11:59 p.m. on December 31, 2012, with the options to renew for two (2) additional one (1) year terms. The parties agree to exercise the first renewal option to extend the Agreement for an additional one (1) year term that shall commence at midnight on January 1, 2013, and shall terminate at 11:59 p.m. on December 31, 2013, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. One renewal option remains to extend the Agreement for an additional one (1) year term."
