

ABC LICENSE W/ CONDITIONS

The Gaslamp Restaurant, 6251 East Pacific Coast Highway

Recommendation Conditions for: A person-to-person transfer of an On-Sale General for bonafide eating place license.

For Census Tract 5776.02, I am recommending the following:

- 1. The permittee shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control.
- 2. No alcoholic beverages shall be consumed on any property adjacent to the licensed premises under the control of licensee.
- 3. The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
- 4. There shall be no exterior advertising promoting or indicating the availability of alcoholic beverages.
- 5. No sound shall be audible from the exterior of the premises in any direction.
- 6. The permittee shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside the establishment at all times.
- 7. Sales, service and consumption of alcoholic beverages shall be permitted only between the hours of 10:00 AM and 1:00 AM each day of the week.
- 8. The quarterly gross sales of alcoholic beverages shall not exceed the gross sales of food during the same period. The licensee shall at all times maintain records which reflect separately the gross sale of food and the gross sale of alcoholic beverages of the licensed business. Said records shall be kept no less frequently than on a quarterly basis and shall be made available to the Department on demand.
- 9. The permittee shall not use the service of promoters at any time.
- 10. The rear door(s) shall be kept closed at all times during the operation of the premises except in cases of emergency and to permit deliveries. Said door(s) not to consist solely of a screen or ventilated security door.

- 11. The permittee shall not require an admission charge or cover charge, nor shall there be a requirement to purchase a minimum number of drinks.
- 12. Trash shall not be emptied into outside trash containers between the hours of 11:00 PM and 10:00 AM.

These conditions were discussed with the applicant and the applicant has agreed to them.
