## SECOND AMENDMENT TO AGREEMENT NO. 34706

THIS SECOND AMENDMENT TO AGREEMENT NO. 34706 is made and entered, in duplicate, as of July 12, 2018, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 11, 2017, by and between JASON ADDISON SMITH CONSULTING SERVICES, INC. DBA JAS PACIFIC, a California corporation ("Consultant"), with a place of business at 201 North Euclid Avenue, Suite A, Upland, California 91786, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed plan review and inspection services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34706 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the Agreement amount by \$34,500 for a total not to exceed amount of \$114,500; and

WHEREAS, the Parties desire to increase the Agreement amount by \$150,000 for a total not to exceed amount of \$264,500;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Two Hundred Sixty-Four Thousand Five Hundred Dollars (\$264,500), at the rates or charges shown in Exhibit "B"."
  - 2. Except as expressly amended herein, all terms and conditions in
