<u>TIME FOR CONTRACT</u>. Contractor shall commence work on a date
to be specified in a written "Notice to Proceed" from City and shall complete all work
within Three Hundred Sixty-Five (365) calendar days thereafter, subject to strikes,
lockouts and events beyond the control of Contractor. To the extent all work is not
completed within three hundred sixty-five (365) days after the date specified in the Notice



to Proceed, the term of the Contract shall be extended and, unless sooner terminated as
provided in this Contract, or unless the work to be performed hereunder is completed
sooner, shall terminate at 11:59 p.m. on December 31, 2009. Time is of the essence
hereunder. City will suffer damage if the work is not completed within the time stated, but
those damages would be difficult or impractical to determine. So, Contractor shall pay to
City, as liquidated damages, the amount stated in the Contract Documents."

2. Except as expressly modified herein, all of the terms and conditions

and effect.
