

1 THIRD AMENDMENT TO AGREEMENT NO. 33913

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 33913 is made and  
4 entered, in duplicate, as of January 17, 2019 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on June  
6 2, 2015, by and between MARY MCGRATH ARCHITECTS, a California corporation  
7 (“Consultant”), with a place of business at 505 17th Street, 2nd Floor, Oakland, California  
8 94612, and the CITY OF LONG BEACH, a municipal corporation (“City”).

9 WHEREAS, City requires specialized services requiring unique skills to be  
10 performed in connection with as-needed architectural services; and

11 WHEREAS, City and Consultant (the “Parties”) entered into Agreement No.  
12 33913 (the “Agreement”) whereby Consultant agreed to provide these services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
14 extend the term to July 19, 2018; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement  
16 to extend the term to July 19, 2019; and

17 WHEREAS, the Parties desire to add \$600,000 to the Agreement for a total  
18 not to exceed amount of \$1,000,000;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
20 conditions herein contained, the Parties agree as follows:

21 1. Section 1.A. of the Agreement is hereby amended to read as follows:

22 “A. Consultant shall furnish specialized services more particularly  
23 described in Exhibit “A”, attached to this Agreement and incorporated by this  
24 reference, in accordance with the standards of the profession, and City shall pay for  
25 these services in the manner described below, not to exceed One Million Dollars  
26 (\$1,000,000), at the rates or charges shown in Exhibit “B”.”

27 2. Except as expressly modified herein, all of the terms and conditions  
28 contained in Agreement No. 33913 are ratified and confirmed and shall remain in full force
