Section 2 of the Contract is hereby amended to read as follows: "2. 21 <u>PRICE AND PAYMENT</u>. City shall pay to Contractor the amount(s) 22 for each Work Order based on the adjustment factor in Contractor's Bid, attached hereto 23 as Exhibit "A"; provided, however, that City shall not pay more than Four Million Dollars 24 (\$4,000,000) for the term of the Contract. Furthermore, no individual Work Order project 25 shall exceed Five Hundred Thousand Dollars (\$500,000)." 26 2. Section 3.A of the Contract is hereby amended to read as follows: 27 "A. The term of this Contract shall begin on March 22, 2017 and 28 shall end on March 21, 2019 or on City's payment of the not-to exceed dollar amount 1 LTV:bg A17-00554
