

1 FIRST AMENDMENT TO CONTRACT NO. 32930

3 THIS FIRST AMENDMENT TO CONTRACT NO. 32930 is made and
4 entered, in duplicate, as of October 28, 2013 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 November 13, 2012, by and between PALP, INC. DBA EXCEL PAVING COMPANY, a
7 California corporation ("Contractor"), whose address is 2230 Lemon Avenue, Long
8 Beach, California 90806, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, pursuant to a "Notice Inviting Bids for in the City of Long
11 Beach, California," dated September, 2012, and published by City, bids were received,
12 publicly opened and declared on the date specified in said Notice; and

13 WHEREAS, the parties entered into Contract No. 32930 for the work
14 described in the bid documents; and

15 WHEREAS, the parties now desire to extend the term;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the parties agree as follows:

18 1. Section 4 of Contract No. 32930 is hereby amended to read as
19 follows:

20 "4. TIME FOR CONTRACT. The term of this Contract shall commence
21 at midnight on January 1, 2013, and shall terminate at 11:59 p.m. on December 31, 2014,
22 unless sooner terminated as provided in this Contract, or unless the services or the
23 Project is completed sooner. Time is of the essence hereunder. City will suffer damage
24 if the work is not completed within the time stated, but those damages would be difficult
25 or impractical to determine. So, Contractor shall pay to City, as liquidated damages, the
26 amount stated in the Contract Documents."

27 2. Except as expressly modified herein, all of the terms and conditions
28 contained in Contract No. 32930 are ratified and confirmed and shall remain in full force






