Seaside Hospital was one of the first major medical facilities in Long Beach, an anchor for the communities of Willmore City, downtown, and the west side, and the birthplace of many prominent Californians and Long Beach residents, including former Mayor Beverly O'Neill.

Seaside eventually moved and became Long Beach Memorial Hospital, continuing to contribute immensely to the health and well-being of our City. The legacy of the original Seaside Hospital is in the successes of the surrounding community, which could not have experienced such prosperity and growth in the 20th century without Seaside as an anchor.

The land for the park was donated by Los Angeles County thanks to the hard work of County Supervisor Don Knabe.

Because of Seaside's profound historical contribution to Long Beach, because of the many citizens, whether famous or unsung, who were born there, and because of the continuing contributions of Seaside's successor facility, Long Beach Memorial Hospital, it is appropriate to name this new park Seaside Park, keeping the legacy and history of this location alive.

DISCUSSION

At the February 1, 2011 City Council meeting, First District Councilmember Robert Garcia, Sixth District Councilmember Dee Andrews, and Seventh District Councilmember James Johnson requested that the new park located at 14th Street and Magnolia Avenue be officially named "Seaside Park" (Attachment A). According to Administrative Regulation AR 8 – 7, the City Council referred the request to the Housing and Neighborhoods Committee and the Parks and Recreation Commission.

The Parks and Recreation Commission considered this request at their February 17, 2011 meeting (Attachment B) and unanimously approved this request.

The Administrative Regulations AR 8 – 7 applies to the naming of all public land, buildings and facilities. AR 8 – 7 provides several policies to guide the consideration of a naming request. The following are those policies:

- The name should incorporate Long Beach whenever important for civic recognition or identification;
- A name in honor of a recognized geographic area, a topographic feature or a historically significant event may be appropriate;
- A name in honor of persons or families who have donated the land or a substantial portion of the improvement costs may be appropriate when applicable;
- A name in honor of a person or persons who have served the nation, the State of California, and/or the City of Long Beach in an exceptional or distinguished manner may be appropriate if warranted by service of major significance;
- A name in honor of a living person, or of a deceased person within one year of their death, is not appropriate, unless the significance of that person's contribution is worthy of an exception to the policy;
- A name in honor of a person is not appropriate when a name in honor of another person has been given to the same site, building or facility in the past;
- A name in honor of a person is not appropriate if that person has been overly recognized in the past; and,
- A name may be selected through a competition or a contest.

In accordance with this regulation, the naming of Seaside Park is in keeping with the naming in honor of a recognized geographic area.

The park was built on the site of the old Seaside Hospital. Seaside Hospital was one of the first major medical facilities in Long Beach, an anchor for the communities of Willmore City, downtown, and the west side, and the birthplace of many prominent Californians and Long Beach residents, including former Mayor Beverly O'Neill.

Seaside Hospital eventually moved and became Long Beach Memorial Hospital, continuing to contribute immensely to the health and well being of our city. 

RECOMMENDATION:

Recommend to the Housing and Neighborhood Committee, and the full City Council, that the new park at 14th Street and Magnolia Avenue be named "Seaside Park."

DISCUSSION

On February 1, 2011, First District Councilmember Robert Garcia, Sixth District Councilmember Dee Andrews and Seventh District Councilmember James Johnson sent a memo (Attachment A) to the Mayor and members of the City Council requesting that the new park, located at 14th Street and Magnolia Avenue (Attachment B), be named "Seaside Park." The Parks and Recreation Commission recommendation will be transmitted to the Housing and Neighborhoods Committee and the full City Council.

The Administrative Regulations AR 8-7 applies to the naming of all public land, buildings and facilities. AR 8-7 provides several policies to guide the consideration of a naming request. The following are those policies:

- The name should incorporate Long Beach whenever important for civic recognition or identification;
- A name in honor of a recognized geographic area, a topographic feature or a historically significant event may be appropriate;
- A name in honor of persons or families who have donated the land or a substantial portion of the improvement costs may be appropriate when applicable;


